# 機構管治 CORPORATE GOVERNANCE

# 引言

市建局極重視機構管治的文化,董事會及各委員會在運作上均力求達致公開、高透明度和問責的高水平。

#### 董事會

董事會由主席及二十位成員組成,成員來自不同背景,包括學術、商務、政府 (屋宇署、民政事務總署、地政總署及規劃署的署長)、法律、政治(包括四位立法會議員),以及地產和社會工作等界別。另外,市建局的行政總監(法例指定同時為董事會副主席)及負責財務與規劃及發展的兩位執行董事皆為其成員。董事會於二零零二年四月至二零零三年三月間召開了九次會議。

## 委員會

市建局為更完善執行其任務,在董事會轄下設立了八個委員會。各委員會由董 事會成員及增選委員組成,按特定的權責範圍運作。各委員會的工作詳情 如下:

#### Introduction

The URA places a high priority on the standard of Corporate Governance and achieving accountability, openness and transparency in the work of its Board and Committees.

# The Board

The URA Board consists of the Chairman and 20 other members from a diversity of backgrounds - academia, business, government (Directors of Buildings, Home Affairs, Lands and Planning), legal, political (four Legislative Council members), property and social work. The Board also includes the URA's Managing Director, who is by law the Deputy Chairman, and the Executive Directors for Finance and Planning & Development. The Board met on nine occasions between April 2002 and March 2003.


#### Committees

The Board has established eight Committees to pursue the purposes of the Authority. Each operates within its specific terms of reference. The Committees comprise both Board members and co-opted members. Details of the Committees are as follows:
